- Carrying out the professional duties of a teacher as circumstances may require and in accordance with School policies, under the direction of the Principal.
- Promoting the achievement of high standards through effective teaching and learning within subjects area(s), preparation, evaluation and action planning.
- Modelling the vision and values of the School;
- Being part of the team driving the development of the School to become an 'outstanding' school.
- Receiving and acting on feedback to build on the strengths and improve personal performance within the School systems.
- Contributing, where appropriate, to implementing policies and practice and to promoting collective responsibility for their implementation.
- Taking into account and constantly reviewing School contextual factors and prior attainment when planning and teaching lessons.
- Working in a cross-curricular way to support subjects across the School in the use of active learning approaches to enrich curriculum and skills delivery.
- Recognising, promoting and celebrating diversity.

## **Responsible for:**

- Supervision and progress of students in allocated classes.
- Supervision of work of any classroom support staff during times they are allocated to classes.

Develop and sustain DEEP LEARNING across the School through:	<ul> <li>Work to student targets and ensure that progress is tracked through a range of strategies.</li> <li>Take account and review School contextual factors and prior attainment when planning and teaching lessons.</li> <li>Reflect on the success of teaching strategies, individual lessons and SoW in meeting the needs of students.</li> <li>Apply current guidelines on effective learning and teaching.</li> <li>Take part in coaching and mentoring programmes to support colleagues and develop own practice.</li> <li>Apply and expand teaching repertoire and feedback to colleagues on effectiveness.</li> <li>Strive to deliver outstanding lessons.</li> <li>Deliver interactive lessons with students.</li> <li>Provide good quality assessment using formative and summative methods in conjunction with the School's AfL policy.</li> <li>Record test results and ongoing teacher assessments, keep portfolios of evidence.</li> </ul>

Develop and sustain DEEP SUPPORT across the School through:	<ul> <li>To comply with the School's Child Safeguarding Procedures and to report concerns to the Designated Child Protection Officer.</li> <li>Take responsibility for upholding standards of behaviour and classroom management within the classroom and the schools environment.</li> <li>Through the role, develop systems which address the social health of students to raise standards.</li> <li>Promote the consistent and fair use of the Consequences system within the classroom and the School environment.</li> <li>Be the first line of contact for parents and carers concerns with regard to their child's performance and well-being.</li> <li>Perform the duties of a Vertical Mentor Tutor if required, including the provision of Information, Advice and Guidance for students.</li> </ul>

It is not a comprehensive statement of procedures and tasks, but sets out the main expectations of the School in relation to the postholder's professional responsibilities and duties.
